Order

Sri J. Raghuma Chary, Bhadradri Kothagudem District has filed a Complaint dated 23-02-2022 which was received by this Commission on 26-02-2022 for not getting the information sought by him from the PIO / O/o the District Transport Officer, Bhadradri Kothagudem District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 24-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. వా కార్గలయంలోని 17 అక్షరాల సెక్షన్ 4(1)(b) బోజో సమాచారాన్ని, లిజిస్టర్-1, లిజిస్టర్-2 లను అణచివేయటం.
2. ప్రభుత్వం నుండి వా కార్గలయానికి వచ్చిన సర్కులరు, మెమోలను మరియు వాటిపై తమరు తీసుకున్న చర్యల వివరాల ప్రతులను అణచివేయటం, వా కార్గలయంలో RTI విజిటింగ్ ప్రవేశంపై తమరు తీసుకున్న చర్యల వివరాల ప్రతులను అణచివేయటం దరఖాస్తు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 10.30 A.M.

The case is called on 17-08-2022. The complainant is absent. The PIO / O/o the District Transport Officer, Bhadradri Kothagudem District is absent. Sri S. Srinivasa Rao, Junior Assistant, O/o the District Transport Officer, Bhadradri Kothagudem District is present and filed affidavit stating that the information was furnished to the complainant vide letter no: A/6834/2021 dated: 14-12-2021 and filed copies of the same before the Commission.

Perused the material papers available on record. The Commission is of the view that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
