## **Order**

Sri T. Srinivasulu, Mahabubnagar District has filed 2<sup>nd</sup> appeal dated: 30-12-2021 which was received by this Commission on 05-01-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Jadcherla Mandal, Mahabubnagar District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Mahabubnagar Division, Mahabubnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 18-03-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

I Telugu Srinivasulu S/o Narayana, of Gollapally Village, humbly requesting you sir, It was came to my knowledge that, my Elders are holding the Tenancy bearing the Survey No.s i.e., 238, 251 and 285 in the Gollapally Village under your Mandal.

**In this regard I wanted to see the actual Tenancy Record in your office with my eyes, and also issue the Xerox copies of the said record, under Right to Information Act, 2005, for which I am herby submitting a Indian Postal Order No. 41 H 901174, for Rs. 100/- (Rupees Hundred only)**

1. Rs. 10/- for information.
2. Rs. 90/- for Xerox and etc. expenses

Hence I request you, please arrange the Date and Time to see the Actual Record of Tenancy in your Office and intimate me under Right to Information Act.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 14-06-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The appellant is absent. The PIO / Smt. M. Venkateshwari, Deputy Tahsildar, Jadcherla Mandal, Mahabubnagar District is present and filed his affidavit stating that the information was furnished vide letter No: A/2711/2021 dated: 28-06-2021 and filed copies of the same before the Commission.

Heard the PIO and perused the material papers available on record and observed that the appellant through his 2<sup>nd</sup> appeal dated: 30-12-2021 stated that the PIO has not furnished the Tenancy Records and requested to allow him for inspection of records.

Keeping in view of the above, the Commission directs the PIO to allow the appellant for verification of records on a mutually fixed date and time by giving a prior intimation to the appellant and furnish the required information to the appellant as sought through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
