## **Order**

Sri Mukesh Tak, Hyderabad has filed a Complaint dated 02-03-2022 which was received by this Commission on 03-03-2022 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, Circle-09, GHMC, Charminar Zone, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 26-02-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

**I Submit that I require the certified copies of the sanctioned plan in respect of the property bearing No. 23-4-568, situated Backside Valmiki Temple, Sultan Shahi, Hyderabad in the year 2008-2009 or the copies of documents applied under BRS Scheme and the necessary information may kindly be furnished U/s. 3 of the Right to Information Act, 2005. The necessary application fee is affixed.**

**Therefore, it is requested to supply the certified copies of the sanctioned plan in respect of the property bearing No. 23-4-568, situated Backside Valmiki Temple, Sultan Shahi, Hyderabad in the year 2008-2009 or the copies of documents applied under BRS Scheme, U/s. 3 of the Right to Information Act, 2005 and the same may kindly be provided to me at earliest.**

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 12.00 P.M.

The case is called on 18-08-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Smt. J. Sukanya, Section Officer, Circle – 7, GHMC, Charminar Zone, Hyderabad is present and filed her affidavit stating that reply was given to the complainant vide letter No: RTI/W23/ACP/ C9/SZ/GHMC/2021 dated: 12-08-2022. The APIO filed copy of the information furnished before the Commission.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
