## **Order**

Sri P. Bhupathi Rao, Hyderabad has filed a Complaint dated: 02-03-2022 which was received by this Commission on 03-03-2022 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Madina, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 13-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- 1). Please supply the STATISTICAL information confirming the Total Number of Stay Orders with Dates of Orders passed by the Hon'ble High Court of Telangana and Subordinate Courts and Tribunals in Telangana State (hereinafter altogether referred to as 'Courts') against the proceedings of demolition initiated and notified under GHMC Act since the separate Telangana State has formed.
- 2). Please supply the STATISTICAL information confirming the Total Number of Stay Orders with dates of Orders expired (automatically expired on completion of six months as ruled by the Hon'ble Supreme Court of India and not extended) which were passed by the 'Courts' against the proceedings of demolition initiated and notified under the GHMC Act since the separate Telangana State has formed.
- 3). Please supply the STATISTICAL information confirming the Total Number of demolitions, initiated and notified under the GHMC Act since the separate Telangana State has formed, to be resumed and not being resumed even after the expiry of the Stay Orders which were passed by the 'Courts' and also the reason(s) / ground(s) behind causing reasonable suspicion of Mal-Administration and Corruption.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 16-09-2022 at 10.30 A.M.

The case is called on 16-09-2022. The complainant is absent. Sri G. Naresh is present representing Sri A. Kranthi Kumar Reddy, Standing Counsel for O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and filed affidavit stating that vide letter ROC No: 414/PIO/JUDL/2021 dated: 20-11-2021 the request of the complainant was rejected.

Perused the material papers available on record.

The Commission upholds the reply of the PIO, the appeal is closed.
