## Order

Sri T. Poshetty, Kamareddy District has filed 2<sup>nd</sup> appeal dated: 03-03-2022 which was received by this Commission on 04-03-2022 for not getting the information sought by him from the PIO – I / O/o the Tahsildar, Banswada Mandal, Kamareddy District, PIO – II / O/o the Tahsildar, Kamareddy Mandal, Kamareddy District, PIO – III / O/o the Assistant Director, Survey and Land Records, Kamareddy District & PIO – IV / O/o the Assistant Director, Survey and Land Records, Nizamabad District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 11-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

2965: Transfer of 456(3) to the PIO/PIO of the following for their respective/connected points by Sy Nos/Sub Nos of Villages there to:

- 1) PIO: Tahsil Office, Banswada
- 2) PIO: Tahsil Office, Kamareddy
- 3) PIO: AD (SSLA); Kamareddy
- 4) PIO: AD (SSLA); Nizamabad
- 5) PIO: AD (SSLA) (Bhadrachalam); Nizamabad

300: Villages/Mandal - Sy Nos/Sub Nos:

- 1) Banswada (C) - Sy No 184-188 and Sy No 245-370.  
Sy No 1335-1346
- 2) Central Nagarum (C) - Sy No 24-28
- 3) Kamareddy (C) - Sy No 808-810.... 5) Derampally - Sy No 206-210 6) Tekrped - Sy No 144-150

300: Information and records of above Sy Nos on following points:

- (i) Dehans (ii) location sketch/village map of 381A and Ghubharati (LPO) (iii) land register of Ghubharati (iv) classed T. Pinnis.
- (v) Akshai Pahani 1954-55 (vi) Sesala Pahani 1955-59 (vii) Pahani year 1960; 1970; 1980; 1990; 2000; 2010-2018 and On line Pahani up to 2021.
- (viii) Faisal Pahani 1960; 1970; 1980; 1990; 2000; 2010-2018
- (ix) All above Sy Nos are Gairam; Govt or own old patta lands.
- (x) If Gairam/Govt whether assigned kuzini or allotted on upset/price or alienated or Govt purchase vide by Govt Treasury Chellan name/Honours.
- (xi) Official/authority by whom such Gairam accorded under specifying the Rev. Act/Rules/GO; File's Proceedings of conditions to comply.
- (xii) Copy of Revenue record get implemented such Govt Gairam.
- (xiii) Official/authority to return; get work back if conditions of Gairam violated by Gairam.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 15-11-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 12.00 P.M.

The case is called on 17-08-2022. The appellant is present and filed his affidavit stating that the PIO has furnished the information. Sri G. Ravi Kumar, Deputy Tahsildar (Elections) is present and filed affidavit of the PIO - I / Sri K. Sangameshwar, Deputy Tahsildar, Banswada Mandal, Kamareddy District stating that the information was furnished to the appellant vide letter No: B/897/2022 dated: 14-8-2022 and filed copy of the reply given along with the acknowledgement receipt before the Commission.

The PIO - II / Deputy Tahsildar, Kamareddy Mandal & District is absent.

Sri B. Amber Singh, Deputy Inspector of Survey is present and filed affidavit of the PIO - III / Sri G. Srinivas, Inspector of Survey, SLR, Kamareddy District stating that the information was furnished to the appellant vide letter No: A1/948/2021 dated: 05-11-2021 and filed copies of the information furnished before the Commission.

Sri M. Venkatesh, Superintendent is present on behalf of the PIO - IV / Sri P. Shyamsundar Reddy, Assistant Director, Survey and Land Records, Nizambad District.

Sri P. Anand Kumar, Divisional Administrative Officer is present and filed his affidavit of the First Appellate Authority / Sri S. Sreenu, Revenue Divisional Officer, Kamareddy Division & District.

Heard both parties and perused the material papers available on record. The appellant stated that he is receipt of the complete information.

Since the information is furnished, the appeal is closed.
