Order

Sri T. Poshetty, Kamareddy District has filed a Complaint dated: 03-03-2022 which was received by this Commission on 04-03-2022 for not getting the information sought by him from the PIO / O/o the District Collector, Kamareddy Collectorate, Kamareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 15-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1) I submit that I am Sri T. Poshetty (SC/65 Yrs), President, Cheyutha Seva Sangam (Regd.VO/ NGO) render service on voluntary base from the issue noticed or brought its notice from genuine needy general public bringing it for redressal at the Govt. / Non Govt. Admn. / Organisation by mediation / intervention.

2) In view of the above I file My 6(1)/(3) RTI Appl. to PIO/APIO O/o. Collector, Dist. Kamareddy (TS) with Rs.10/- Court Fee Stamp towards Appl. Fee. to furnish directly or the same transferred U/s. 6(3) to the PIO, O/o Tahsildar, Nasurullahbad by copy to me for the following: 1) points of information.

Of Tahsil Office: Nasurullahbad

i) ATR/Action taken report on my Appl. dt. 18.02.2022 to Tahsildar, Nasurullahbad.

ii) Physical copies for the year 2016-17 to 2020-21 for S.No 312/10/1; 312/10/2; 312/10/3; 312/10/4; 312/10/5; 312/10/6 Dist. No.

iii) Physical copies for the year 2016-17 to 2020-21 for S.No 312/80; 312/81; 312/82; 312/83; 312/84; 312/85; 312/86; 312/87; 312/88; 312/89; 312/90; 312/91; 312/92; 312/93; 312/94; 312/95; 312/96; 312/97; 312/98; 312/99; 312/100 Dist. No.

iv) Extracts of records/registers/Enquiry reports & deposition statements on notices issued/served on concerned of above S.No's during land/land records updation programme/Bhu Franchisee from Sep. 2017 onwards to latest ongoing Sharami programme.

v) Final decision/orders passed for all above S.No's on which case finalised to issue a certificate or not by inclusion in Part B's 202

vi) Procedure possibility for inclusion in Sharami all above S.No's including Rythu Bandu and Rythu Bheema

of Rythu Bheema for 1954-55; Rythu Bheema for 1955-59 at District level above S.No's.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 12.00 P.M.

The case is called on 17-08-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. Sri K. Sai Bhujang Rao, Superintendent is present on behalf of the PIO / Sri K. Chandra Mohan, Additional Collector / District Revenue Officer, Kamareddy District and filed his affidavit stating that vide letter No: H4/7038/2021 dated: 16-11-2021 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / O/o the Tahsildar, Nasurullahbad Mandal and the PIO / Assistant Director, Survey and Land Records, Kamareddy District with a request to furnish the information to the complainant. The representative failed to submit the copy of the letter dated: 16-11-2021 before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO / O/o the Tahsildar, Nasurullahbad Mandal, Kamareddy District and the PIO / Assistant Director, Survey and Land Records, Kamareddy District to furnish the action taken on the complaint dated: 18-02-2020 to the complainant duly attesting within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
