Order

Sri T. Poshetty, Kamareddy District has filed a Complaint dated: 03-03-2022 which was received by this Commission on 04-03-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Gandhari Mandal, Kamareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 15-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1) I submit that I am Sri T.Poshetty (SC/65 Yrs), President, Cheyutha Seva Sangam (Regd.VO/ NGO) render service on voluntary base from the issue noticed or brought its notice from genuine needy general public bringing it for redressal at the Govt. / Non Govt. Admn. / Organisation by mediation / intervention.

2) In view of the above I file My 6(1)/(3) RTI Appl. to PIO/APIO O/o. Collector, Dist. Kamareddy (TS) with Rs.10/- Court Fee Stamp towards Appl. Fee. to furnish directly or the same transferred U/s 6(3) to the PIO, O/o Tahsildar, Gandhari Mandal by copy to me for the following points of information.

- i) ATR/Action taken report on my Appl. dt. 18-02-2022 to Tahsildar, Gandhari Mandal
 - ii) Poshetty copies for the year 2016-17 to 2020-21 for Sy No: 541; 542/4; 543/5; 58/2; 540/10; 952/3; 963/24; 991/2 Gandhari Mandal
 - iii) Extracts of records / Registers / Enquiry reports / Applications / Correspondence on matters issued / served on concerned of above Sy Nos under the Land/Record updation Programme / Other Provisions from Sep. 2017 onwards to latest ongoing Government's programme.
 - iv) Final Decision / orders passed for all above Sy Nos on which case finalized to issue a - pass book or not by inclusion in P.C. A-2008.
 - v) a - pass book No and Ration Card change no if issued.
 - vi) Final decision / orders passed for above Sy Nos on which case finalized to issue a - pass book or not by inclusion in P.C. A-2008.
 - vii) Procedure's possibility for inclusion in Dhammi above Sy Nos including Ration Card; Ration Book etc.
 - viii) Khassan Patnam No: 1954-55 and 1954-59 and 1955-59 for above Sy Nos at Gandhari Mandal.

3) I therefore request to kindly dispose of the matter of my 6(1)/(3) Appl. under the Act. appropriately.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 12.00 P.M.

The case is called on 17-08-2022. The complainant is present and filed his affidavit stating that the PIO has furnished part information. The PIO / Sri A. Ravi, Deputy Tahsildar, Gandhari Mandal, Kamareddy District is present and filed his affidavit stating that vide letter No: B/662/2022 dated: 08-08-2022 the information is brought to the Commission and is ready to be furnished to the complainant.

Heard both the parties and perused the material papers available on record. The PIO furnished the information to the complainant before the Commission and after verifying, the complainant stated that the information is incomplete.

The Commission directs the PIO to furnish the balance information to the complainant duly attesting within 2 (Two) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO / Sri A. Ravi, Deputy Tahsildar, Gandhari Mandal, Kamareddy District and the then PIO / Sri B. Ramdas, Deputy Tahsildar, Gandhari Mandal, Kamareddy District for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.
