Order

Sri B. S. Narsimha Raju, Guntur District has filed a Complaint dated: 04-03-2022 which was received by this Commission on 05-03-2022 for not getting the information sought by him from the PIO / O/o the District Collector, Nalgonda Collectorate, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 10-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. Sri D. Sunil Kumar, Senior Assistant is present and filed affidavit of the PIO / Sri A. Bhaskar Rao, District Revenue Officer (FAC), O/o the District Collector, Nalgonda District stating that the information was furnished to the complainant vide letter No: A5/9784/2022 dated: 01-02-2022 and filed copies of same before the Commission.

Heard both the parties and perused the material papers available on record. The complainant stated that the PIO has not furnished the complete information. The APIO submitted that the information would be available with the PIO / Personal Officer, O/o the Telangana State GENCO, Hyderabad. The PIO ought to have transferred the application to the concerned Public Authority with a request to furnish the information to the complainant.

The Commission directs the PIO to give a specific reply and transfer the application u/s 6(3) of the RTI Act to the PIO / Personal Officer, O/o the Telangana State GENCO, Hyderabad furnish the information to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
