Order

Sri G. Munappa, Mahabubnagar District has filed a Complaint dated: 04-03-2022 which was received by this Commission on 05-03-2022 for not getting the information sought by him from the PIO / O/o the Sub-Registrar, Jadcherla Mandal, Mahabubnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 24-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

to 2000, 2001, 2002, 2003, 2004,

from 2000 to 7/6/2007 Minkly done.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 12.00 P.M.

The case is called on 01-09-2022. The complainant is present and filed his affidavit stating that the PIO has furnished part information. The PIO / Sri Bogul Anand, Sub-Registrar, Jadcherla Mandal, Mahabubnagar District is present and filed his affidavit stating that reply was given to the complainant vide letter No: 61/RTI/2022 dated: 23-02-2022 informing that the information sought is priced material and can be obtained by paying Rs. 500/- (below 30 years) and Rs. 1000/- (above 30 years) or can be obtained for free in their official website: www.Registration.telangana.gov.in, the PIO filed copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record. The PIO submitted that the available information is furnished and the remaining information can be obtained from the PIO / O/o the Tahsildar, Bhoothpur Mandal, Mahabubnagar District.

The Commission directs the PIO / O/o the Tahsildar, Bhoothpur Mandal, Mahabubnagar District to furnish the information to the complainant duly attesting within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
