Order

Sri S. Mohan Reddy, Hyderabad has filed 2nd appeal dated: 05-03-2022 which was received by this Commission on 08-03-2022 for not getting the information sought by him from the PIO / O/o the Child Development Project Officer, ICDS Project, Metpally, Jagitial District and 1st Appellate Authority / O/o the District Welfare Officer, Women Children Disabled and Senior Citizen Department, Jagitial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 08-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 3 Food Return (Letter & సంబంధం) కి సంబంధించిన కళిచుగా
Food Return కి సంబంధించిన / గాం Incharge, CDPO, S.A.S.T, S.A.S.S etc) Letter or
కళిచు, అభివృద్ధి, అనుకూలమైన వసూలు ఇస్తారు.
- 4 STO Register Pages for 2013 April to March 2014. or P.D. TO Draw చేసిన period
05-11-2013 to 2/2014.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 04-12-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 10.30 A.M.

The case is called on 25-08-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. G.V. Thirumala Devi, CDPO, ICDS Metpally Project, Jagityal District is present and filed her affidavit stating that the information was furnished to the appellant vide letter No: RTI/140/2021 dated: 10-11-2021 and filed copy of the letter along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to give point wise reply and furnish the information to the appellant within Fifteen (15) days from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
