## **Order**

Sri K. Rajesh Kumar, Hyderabad has filed 2<sup>nd</sup> appeal dated: 09-03-2022 which was received by this Commission on 09-03-2022 for not getting the information sought by him from the PIO / O/o the District Welfare Officer, Chamber 26, Burgupally. Collector, Complex, Vikarabad District and 1<sup>st</sup> Appellate Authority / O/o the District Welfare Officer, Chamber 26, Burgupally. Collector, Complex, Vikarabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 12-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

*I, K. Rajesh Kumar, working as District child protection Officer (Depo) in Women & child welfare Department, Vikarabad District. As per Honorable Highcourt, Telangana order no. IA.No. 01/2020 in WP/No. 12278/2020. Dt. 11.08.2020. I have been in the Service till date. It is requested you madam as per cited above subject kindly provide information & certain documents/certificates as per Right to Information Act, 2005. I have been Employed under JJ Act and District magistrate & collector who is the chairman for the District child protection Society and himself/herself is the immediate authority under my cadre as per JJ Act. Kindly it is requesting the Certain Information provision as stipulated period under RTI Act, 2005.*

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 08-11-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 10.30 A.M.

The case is called on 25-08-2022. The appellant is absent. The PIO / Smt. K. Lalitha Kumari, District Welfare Officer, Collectorate Complex, Vikarabad District is present and filed her affidavit stating that the information was furnished to the appellant vide letter No: 23/DWO/VKB/2022 dated: 08-08-2022 and filed copy of the letter along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO has furnished the available information to the appellant.

In view of the above, the appeal is closed.
