Order

Sri S. Ramulu Goud, Mahabubnagar District has filed 2nd appeal dated: 10-03-2022 which was received by this Commission on 10-03-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Bomraspet Mandal, Mahabubnagar District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Mahabubnagar Division, Mahabubnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 24-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

నేను యస్. రాములుగౌడ్ తండ్రి ... గుంటూరు జిల్లా, నివాసం: మయ్యవల్లిపాడు, గ్రామం: మయ్యవల్లిపాడు, పట్టణం: మయ్యవల్లిపాడు, తహసీల్దార్, బొమ్మరసేపటి మండలం, మహబూబ్ నగర్ జిల్లా, తెలంగాణ రాష్ట్రం, ప్రభుత్వం వద్దకు సమాచారం కోరడం కోసం ప్రార్థన చేశాను. తమరితో చేయు మనవి ఏమనగా, ఈ దరఖాస్తులో పేర్కొనబడిన సమాచారం హక్కు చట్టం 2005లోని నిబంధన 02 ఉప నిబంధన ఎఫ్, ఐ మరియు జె ప్రకారం రికార్డు పరంగా ఉన్నందున ఈ చట్టంలోని నిబంధన 07(1) కింద / ప్రకారం వ్యక్తి స్వేచ్ఛ జీవన స్వేచ్ఛ వరిధి కింద ఈ దరఖాస్తు అందిన వెంటనే 24 / 48 గంటలలో నేను కోరిన సమాచారం ఎలాంటి మినహాయింపు లేకుండా ఇవ్వాలని / ఇప్పించాలని కోరుచున్నాను.

and more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 08-02-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 12.00 P.M.

The case is called on 01-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri K. Ravi, Deputy Tahsildar, Bomraspet Mandal, Mahabubnagar District is present and filed his affidavit stating that he has taken charge recently and requested to give time to furnish the information.

Heard both the parties and perused the material papers available on record. The Commission cannot accept the submission made by the PIO.

The Commission directs the PIO to furnish the information to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO / Sri K. Ravi, Deputy Tahsildar, Bomraspet Mandal, Mahabubnagar District and the then PIO / Smt. Shaheda Begum, Deputy Tahsildar, Bomraspet Mandal, Mahabubnagar District presently working as Tahsildar, Doma Mandal, Vikarabad District for not furnishing the information to the appellant with the stipulated period of 30 days and for not appearing before the Commission for the hearing. The action on the **Show Cause Notice** will be dealt separately.

With the above direction, the appeal is closed.
