Order

Sri G. Ramesh, Mancherla District has filed 2nd appeal dated: 07-03-2022 which was received by this Commission on 10-03-2022 for not getting the information sought by him from the PIO / O/o the Director of Public Libraries, Government of Telangana, Afzalgunj, Hyderabad and 1st Appellate Authority / O/o the Director of Public Libraries, Government of Telangana, Afzalgunj, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 01-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 05-01-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 10.30 A.M.

The case is called on 26-08-2022. The appellant is present and filed his affidavit stating that the PIO has furnished part information. The PIO / Smt. C. Aparna, Assistant Director, O/o the Director of Public Libraries, Government Of Telangana, Hyderabad is present and filed her affidavit stating that the information was furnished to the appellant vide letter Rc. No: 12-RTI/2020 dated: 15-12-2021 and on filing 1st appeal dated: 05-01-2022 the same was once again furnished to the appellant vide letter Rc. No: 12-RTI/2021 dated: 02-02-2022. The PIO filed copy of the information furnished to the appellant along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission is of the view that the information furnished by the PIO holds good.

Since the information is furnished, the appeal is closed.
