## Order

Sri A. Srinivasulu, Mahabubnagar District has filed 2<sup>nd</sup> appeal dated: 07-03-2022 which was received by this Commission on 11-03-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Midjil Mandal, Mahabubnagar District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Mahabubnagar Division, Mahabubnagar District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 01-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) ఎన్నికలకు సంబంధించిన వేతనాల కిరాయి నమోదు (27/1/2022), 27/1/2022, 27/1/2022.
- 2) ఎదురు నమోదు పై పట్టణ పాలిసెస్ కు సంబంధించిన ఎన్నికల ఫలాల నమోదు, ఎన్నికల ఫలాల, మరల 10 నమోదు (వారసత్వం, గిట్టి, ఇంకా ఫైలు, వ్యవహారం)
- 3) సదరు ఎన్నికలకు సంబంధించిన సమాచారం, ఫైలు లిస్టులు, ఫైలు లిస్టులు, వ్యవహారం.
- 4) ఎన్నికలకు సంబంధించిన ఫైలు లిస్టు (File) లిస్టులు.
- 5) ఎన్నికలకు సంబంధించిన ఫైలు లిస్టులు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 27-01-2022 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 12.00 P.M.

The case is called on 01-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Ms. M. Geetha, Deputy Tahsildar, Midjil Mandal, Mahabubnagar District is present and filed her affidavit stating that reply was given to the appellant vide letter No: B/RTI/83/2021 dated: 21-09-2021 informing that the information cannot be furnished as per Section 8(1)(j) of the RTI Act 2005 and on filing 1<sup>st</sup> appeal dated: 27-01-2022 the First Appellate Authority / O/o the Revenue Divisional Officer, Mahabubnagar Division & District vide letter No: L/RTI/564/2022 dated: 31-01-2022 directed the PIO to furnish the information to the appellant and a reply was given vide letter No: B/RTI/01/2022 dated: 03-02-2022 requesting to inform the file number and on 20-06-2022 the appellant was requested to visit their office for inspection of records, but has not taken any information. The PIO filed copies of the letter before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to allow the appellant for verification of records on a mutually fixed date and time by giving a prior intimation to the appellant and furnish the required information or give point wise reply to the appellant as sought through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
