Order

Sri K. Ramesh, Nizamabad District has filed a Complaint dated: 07-03-2022 which was received by this Commission on 11-03-2022 for not getting the information sought by him from the PIO / O/o the Revenue Divisional Officer, Nizamabad Division, Nizamabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 20-07-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- ① నిజామాబాద్ రెవెన్యూ డివిజన్ కి క్షాత్రా తాంబిలయిని సంబంధించిన 17 ప్రాజెక్టు ఓ సంబంధించిన 4(1) బ ప్రతిని ఉపబేంగా భృత్యులెంబి ఇవ్వగలరు.
- ② నిజామాబాద్ జిల్లా సబ్ డివిజన్ మండల రెవెన్యూ తాంబిలయిని ఎఫ్.ఎ. నిజామాబాద్ లోని డి.ఎ.ఎ. స. లాథా యిన్. స. రి. సెర్వీస్ బుక్ ఖెరోకొఫ్ కెప్యీస్ ని భృత్యులెంబి ఇవ్వగలరు.

The PIO / O/o the Revenue Divisional Officer, Nizamabad Division, Nizamabad District vide Lr. No. A4/3968/2020 dated. 26-08-2020 transferred an application U/s 6(3) of the RTI to O/o the Tahsildar, Navipet Mandal, Nizamabad District with a request to furnish the information to the Complainant.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 10.30 A.M.

The case is called on 15-09-2022. The complainant is present and filed his affidavit stating that the PIO has furnished part information. The APIO / Sri B. Devi Singh, Senior Assistant, O/o the Tahsildar, Navipet Mandal, Nizambad District is present and filed his affidavit stating that reply was given to the complainant vide letter No: A/464/2021 dated: 25-09-2021 informing that the information sought is of 3rd party and without taking their consent as Section 11 of RTI Act 2005 the information could not be furnished. The APIO filed copy of reply along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record.

The complainant stated that the PIO has not furnished the complete information, the PIO submitted the information is brought to the Commission and permissible information was furnished to the complainant before the Commission. The Commission is of the view that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
