## Order

Sri B. Ravi Kumar, Sangareddy District has filed a Complaint dated: 11-03-2022 which was received by this Commission on 14-03-2022 for not getting the information sought by him from the PIO / Gram Panchayat Secretary, Suraram Village, Sadasivapet Mandal, Sangareddy District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 05-03-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

పనులు గురుంచి బడ్జెట్ ఎంతమంజూరయ్యింది ఇ  
బడ్జెట్ లో ఏ ఏ పనులు చేసినారో తెలుపగలరు.
- ④ ఈ గ్రామ పనులు చేయడానికి ఏ కాంట్రాక్టరును టెండర్  
వ్వారా ఇవ్వడం జరిగింది వారి పేరు, చరునామా -  
తెలుపగలరు

and more few points.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 10.30 A.M.

The case is called on 26-08-2022. The complainant is absent. The PIO / Sri A. Pradeep Kumar, Panchayat Secretary, Suraram Village Sadasivapet Mandal, Sanga Reddy District is present and filed his affidavit stating that vide letter No: 01/RTI/2020/Pa dated: 27-03-2021 while furnishing the available information the appellant was requested to pay Rs. 4,584/- for Xerox charges for point No: 1, 3 & 10 and obtain the required information and for the remaining information the complainant was requested to approach the Tahsildar office, since the appellant did not pay the requisite fee the said information was not furnished. The PIO filed copy of the letters before the Commission.

Heard the PIO and perused the material papers available on record. The Commission upholds the reply of the PIO and advised the appellant to pay the requisite fee and obtain the information or seek specific information so as to enable the PIO to furnish the same.

In view of the above, the appeal is closed.
