Order

Sri Erragati Chandraiah, Komarambheem Asifabad District has filed 2nd appeal dated: 11-03-2022 which was received by this Commission on 15-03-2022 for not getting the information sought by him from the PIO / O/o the Mandal Educational Officer, Dahegaon Mandal, Komarambheem Asifabad District and 1st Appellate Authority / O/o the District Educational Officer, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 21-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

2. కు పక్కలూరి కు Privat School ప్రాసెసంగాలతో పబ్లిష్డ్ ప్రకారం ఇల్లీగల్ SFT వంట Privat School కి ప్రకటన ఇవ్వడం వంట ప్రకారం కావలసిన SFT వంట.
3. కు పక్కలూరి కు Privat School లో Lecturer ను నియమించే ప్రక్రియ వివరించే డిటెయిల్డ్ వివరాలు వారి Certificates కి కొన్ని కాపీలు లను సం. 2010 నుండి నేటి వరకు ఇవ్వగలరు.
4. కు పక్కలూరి కు Privat School లకు కేజీ ఆడిట్ ఇవ్వడం వివరించే రిపోర్టును 2010 నుండి నేటి వరకు ఇవ్వగలరు. School wage

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 01-11-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 12.00 P.M.

The case is called on 26-08-2022. The appellant is absent, but filed his affidavit stating that the PIO has not furnished the information. The PIO / Mandal Educational Officer, Dahegoan Mandal, Komaram Bheem Asifabad District is absent, but informed over phone that the information pertains various schools in the Mandal and the same was transferred with a request to furnish the information and the same was furnished to the appellant vide letter No: RTI/12/2022 dated: 22-08-2022 by hand.

Perused the material papers available on record. The appellant on the letter dated: 22-08-2022 while taking the information stated that the PIO has furnished part information. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005 and for not appearing before the Commission for the hearing held on 26-08-2022. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the available and held information pertaining to his office only (keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
