Order

Sri B. Raji Reddy, Jagityal District has filed a Complaint dated 10-03-2022 which was received by this Commission on 15-03-2022 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Mancherial Municipality, Mancherial District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 28-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1) మీ కార్యాలయంలో సమాచార హక్కు చట్టం 2005 సెక్షన్ 4(1)(b) ప్రకారం 17 అంశాలకు సంబంధించి సం॥ 2018, సం॥ 2019, సం॥ 2020, సం॥ 2021 సంబంధించి తెలుగులో ప్రచురించబడిన సంచికల యొక్క టిరాక్స్ కాఫీల సర్టిఫైడ్ సమాచారం నా చిరునామాకు పంపగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The complainant is absent. The PIO / Sri K. Vijay Kumar, Manager, O/o the Municipal Commissioner, Mancherial Municipality, Mancherial District is present and filed his affidavit stating that the complete information is brought to the Commission and is ready to be furnished to the appellant.

Heard both the parties and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the complainant duly attesting immediately on the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
