Sri P. Anvesh, Jayashankar Bhupalapalli District has filed 2<sup>nd</sup> appeal dated: 09-03-2022 which was received by this Commission on 19-03-2022 for not getting the information sought by him from the PIO / O/o the Child Development Project Officer, ICDS, Mahadevpur Village & Mandal, Jayashankar Bhupalapalli District and 1<sup>st</sup> Appellate Authority / O/o the Project Director, ICDS Bhupalapalli, Jayashankar Bhupalapalli District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 05-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 07-02-2022 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 10.30 A.M.

The case is called on 25-08-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. R. Radhika, CDPO, ICDS Mahadevpur, Prof. Jayashankar Bhupalapally District is present and filed her affidavit stating that part information was furnished to the appellant vide letter No: A/RTI-1/2021 dated: 25-01-2022 and complete information was furnished vide letter No: A/RTI-1/2022 dated: 22-08-2022 and filed copy of the same before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to furnish the information once again to the appellant within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
