Order

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed 2nd appeal dated: 14-03-2021 which was received by this Commission on 19-03-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Koutala Mandal, Komarambheem Asifabad District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Kagaznagar Division, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 26-08-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. మీ కార్యాలయము ద్వారా జరిగిన total land transition 01-01-2017 నుండి నేటి వరకు number ను year వారీగా ఇవ్వగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 02-11-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 10.30 A.M.

The case is called on 18-08-2022. The appellant is absent. The PIO / Sri B. Ramlal, Deputy Tahsildar, Koutala Mandal, Komaram Bheem Asifabad District is present and filed his affidavit stating that reply was given to the appellant on 17-05-2022, but copy of the same is not traced.

Heard the PIO and perused the material papers available on record. Upon not filing the documentary evidence of furnishing the information to the appellant, the Commission cannot accept the submissions of the PIO. The Commission took a serious view against the PIO and warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the appellant (keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
