## **Order**

Sri Mohd Ashraf, Sirpur-Kagaznagar has filed a Complaint dated 14-03-2022 which was received by this Commission on 19-03-2022 for not getting the information sought by him from the PIO / O/o the Commissioner & Director of School Education, Saifabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 02-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

District Educational Office Adilabad conduct the inquiry and submit the report along with specific remarks to The Director of School Education Hyderabad vide letters numbers Rc.No.B1/3060/TTC-2018/2019, dt: 05-03-2020, Rc.No.B1/3060/TTC-2018/2019, dt: 16-08-2021 and Rc.No.B1/3060/TTC-2018/2019, dt: 29-10-2021 and The Regional Joint Director of School Education, Warangal submit the report along with specific remarks to The Director of School Education Hyderabad vide letters numbers Proc Rc. No. 3997/B4/2018, dt: 20.02.2019 and Proc Rc. No. 3997/B4/2018, dt: 28-12-2021 ఇచ్చిన reports ఆధరంగా నేను మీ కార్యాలయములో 12-11-2021 రోజున Head Master ZPZZ U/M Asifabad ద్వారా సమర్పించిన ప్రాతినిధ్యం / Complaints పై Office Manual Rules పై Supreme Court's Orders No. 854 of 1975 for " Rule Of Law ", Orders No. 2707 of 2011 for " Arbitrary Exercise Of Power " & Orders No. 3501 of 2015 for " Fairness of Trail " Office Manual Rules ప్రకారం తీసుకున్న చర్యల ప్రతులను along with Note File with Rule Position తో పాటు మీకు సమర్పించిన ప్రతులు ఇవ్వగలరు. వారు మీ ఆదేశాల ను: బీబిఆర్ చేసిన చో వారి పైన మీరు తీసుకున్న చర్యల ప్రతులు ఇవ్వగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 26-09-2022 at 10.30 A.M.

The case is called on 26-09-2022. The complainant is absent. The APIO / Sri P. L. Kiran, Senior Assistant, O/o the Commissioner and Director of School Education, Saidabad, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter No: 221/Ser.III-2/RTI/2022 dated: 23-05-2022 informing that the information sought cannot be furnished as per Section 8(1)(j) of the RTI Act 2005. The APIO filed copy of the same before the Commission.

Heard the APIO and perused the material papers available on record.

Since the APIO informed the factual position to the appellant, the appeal is closed.
