Order

Sri K. Somashekhar Rao, Hyderabad has filed 2nd appeal dated: 17-03-2022 which was received by this Commission on 21-03-2022 for not getting the information sought by him from the PIO – I / O/o the Tahsildar, Banswada Mandal, Kamareddy District, PIO – II / O/o the Nodal Officer, Double Bed Room, Kamareddy District & PIO – III / O/o the District Collector, Kamareddy Collectorate, Kamareddy District and 1st Appellate Authority / O/o the District Collector, Kamareddy Collectorate, Kamareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 26-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. కామారెడ్డి జిల్లా కలెక్టర్ గారు బానాస్వడ మండలం లో డబుల్ బెడ్ రూమ్ కేటాయించిన లభిదారుల లిస్టులు, లభిదారులను ఆమోదించిన తేదీ ఆమోదించిన ప్రొసీడింగ్ కాపీ లు సర్టిఫై చేసి 2015- 2016 , 2016-2017, 2017-2018, 2018-2019, 2019-2020, 2020-2021, 2021-2022 సంవత్సరాలవి అందించగలరు.
2. బానాస్వడ మండలం శాడోల్ శివారు లోని సర్వే నెంబర్ లు 973 /1/2/3/4, మరియు 980/1/2 విస్తీర్ణము (3. 06) కు సంబంధించిన ఇంటి ఫులము లభిదారుల వివరాలు, కేటాయింపు గురించి మండల తహసీల్దార్ గారు పంపిన ఫైల్, జిల్లా కలెక్టర్ గారు కేటాయింపులు చేసిన ప్రొసీడింగ్స్ సర్టిఫైడ్ కాపీ లు, అందించగలరు . (మండల తహసీల్దార్ బానాస్వడ గారు సర్వే నెంబర్ లు 973 /1/2/3/4, మరియు 980/1/2 విస్తీర్ణము (3. 06) కు సంబంధించి కలెక్టర్ గారికి పంపినట్లు తెలుపుచు సమాచార హక్కు దరఖాస్తు దారునికి పంపిన రిపై కాపీ జతచేయవలెనది)

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 27-08-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 12.00 P.M.

The case is called on 17-08-2022. The appellant is present and filed his affidavit stating that the PIO has furnished part information. Sri G. Ravi Kumar, Deputy Tahsildar (Elections) is present and filed affidavit of the PIO - I / Sri K. Sangameshwar, Deputy Tahsildar, Banswada Mandal, Kamareddy District stating that the information was furnished to the appellant vide letter No: D/273/2021-24 dated: 06-11-2021 and filed copy of the reply given along with the postal receipt before the Commission.

Sri Vasam Prasad, Deputy Executive Engineer, Double Bed Room, Kamareddy District is present on behalf of the PIO - II / Sri K. Chandra Mohan, Additional Collector / District Revenue Officer, Kamareddy District and filed his affidavit stating that the information was furnished to the appellant vide letter No: 11/2BHK/2021 dated: 06-05-2022 and filed copies of the same before the Commission.

Sri K. Sai Bhujang Rao, Superintendent is present on behalf of the PIO - III / Sri K. Chandra Mohan, Additional Collector / District Revenue Officer, Kamareddy District and filed his affidavit stating that the subject matter is related to the PIO / Nodal Officer, 2BHK, Kamareddy District and the PIO / Tahsildar, Banswada Mandal, Kamareddy District hence the same was transferred u/s 6(3) of RTI Act 2005 with a request to furnish the information to the appellant.

Heard both the parties and perused the material papers available on record.

The appellant stated that the information furnished by the PIOs is incomplete.

The Commission directs the PIO / Deputy Tahsildar, Banswada Mandal, Kamareddy District to furnish the balance information to the appellant duly attesting within 2 (Two) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
