Order

Smt. K. Gouthami, Ranga Reddy District has filed 2nd appeal dated: 21-03-2022 which was received by this Commission on 21-03-2022 for not getting the information sought by her from the PIO / O/o the Superintendent, Prohibition & Excise, Nalgonda District and 1st Appellate Authority / O/o the Superintendent, Prohibition & Excise, Nalgonda District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 22-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application:

I am Meerza Gousia Begum @ Gouthami w/o Kola Nagarajuna - PC 1451
90 Kola Saikolaiyah
prohibition and excise constable Nalgonda - N.L.G.

The case is moving Mc. 57/11 at
L.B.N family court Hyd. against Kola Nagarajuna,
I am petitioner of Mc. 57/11, I need to salary
certificate of Kola Nagarajuna for this case.
I want salary particulars month of Sept - 2021
I want salary certificate and details
from your office. correct copies of Treasury.

I am requesting that kindly issue
the salary certificate and salary details of
Kola Nagarajuna for RTI purpose within
two days. Next adjournment 22-10-2021
* Kindly issue the salary certificate and details.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 27-12-2021 before the 1st Appellate Authority requesting him to furnish the information sought by her u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing her 1st appeal, she preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The appellant is absent. The PIO / Sri B. Chanakya Assistant Prohibition & Excise Superintendent, Nalgonda District is present and filed his affidavit stating that vide letter No: 319/2021/D dated: 08-11-2021 as per Section 11 of RTI Act 2005 a letter was addressed the 3rd party with a request to give his consent whether to furnish the information sought or not and on 27-11-2021 the 3rd party requested not to give any such information and vide letter No: 294/2021/D dated: 27-11-2021 the same was informed to the appellant that the information sought could not be furnished as per section 8(1)(j) of RTI Act 2005. The PIO filed copies of the same before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to furnish the information to the appellant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
