Order

Sri J. Shivaji, Adilabad District has filed a Complaint dated: Nil which was received by this Commission on 22-03-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Utnoor Mandal, Adilabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 28-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 10.30 A.M.

The case is called on 18-08-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri V. Bhujang Rao, Deputy Tahsildar, Utnoor Mandal, Adilabad District is present and filed his affidavit stating that reply given to the appellant vide letter No: RTI/A/93/2022 dated: 05-02-2022 informing that the information sought by the appellant is of 3rd party and the information would be furnished only to the Legal Hires of their family.

Heard both the parties and perused the material papers available on record. The appellant stated that a representation was filed before the Tahsildar on 16-04-2022 which was signed by all the legal hires of the Family requesting to furnish the death certificate. The appellant filed copy of the representation before the Commission and a copy of the same was given to the PIO.

The Commission directs the PIO to furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
