Order

Sri Prasad Babu, Secunderabad has filed 2nd appeal dated: 21-03-2022 which was received by this Commission on 22-03-2022 for not getting the information sought by him from the PIO / O/o the District Panchayat Officer, Sangareddy District and 1st Appellate Authority / O/o the District Panchayat Officer, Sangareddy District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 29-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- I. In my application for information dated 09.11.2021, I had asked for the information, as per the copy enclosed. This has been received by the PIO on 09.11.2021. PIO on 16.11.2021 has transferred the application to the APIO & PIO& MPO, MPP Patancheru to provide the requisite information to me.
- II. PIO, Panchayat Secretary, G.P. Nandigama, Patancheru Mandal, Sanga Reddy, vide letter No. 6/GPN/2021 dated 16.12.2021, has provided the copy of layout and sale deed of (1) Kota Venkatesh (2) Kota Venkata Sudhakar Rao (3) N Malakondaiah (4) T Lakshmi Prasana (5) Kottata venkateswaralu (6) B Koteswara Rao (7) J Venkatsh & T Satyanarayana
- III. I am not satisfied by the information provided to me as these are not relevant as far as my request for information is concerned.
- V. As such I request to give the information forthwith.

The PIO / O/o the DPO, Sangareddy District vide Lr. No. 204/2021/A1-Pts, dated. 11-02-2022 transferred a application U/s 6(3) of the RTI Act to Gram Panchayat Secretary, Nandigama Village, Patancheru Mandal, Sangareddy District & O/o the MPP, Patancheru Mandal, Sangareddy District with a request to furnish the information to the appellant.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 11-02-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 10.30 A.M.

The case is called on 26-08-2022. The appellant is absent. The PIO / Smt. S. Padmavathi, Panchayat Secretary, Nandigama Village and the First Appellate Authority / Sri M. Hari Shankar, Mandal Panchayat Officer, Patancheru Mandal, Sanga Reddy District are present and filed their affidavits stating that the available information was furnished to the appellant vide letter No: 6/GPN/2021 dated: 16-12-2021 and on filing 1st appeal dated: 29-12-2021 an order was passed by the First Appellate Authority / O/o the District Panchayat Office, Sanga Reddy District vide letter Proc. No: 204/2021/A1-Pts dated: 11-02-2022 to provide point wise reply and accordingly the same was given vide letter No: 6/GPN/2022 dated: 24-02-2022. The PIO filed copy of the information / reply furnished to the appellant before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO has not given reply for all the points sought through 6(1) application dated: 09-11-2021.

Hence, the Commission directs the PIO to give point wise reply to the appellant (keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
