Order

Sri Jammi Venkateshwarlu, Khammam District has filed 2nd appeal dated: 30-12-2021 which was received by this Commission on 07-01-2022 for not getting the information sought by him from the PIO / Managing Director, O/o the TSEWIDC, 4th Floor, Rajiv Vidya Mission, SCERT Compound, Opp. E-Gate, L.B. Stadium, Hyderabad and 1st Appellate Authority / Managing Director, O/o the TSEWIDC, 4th Floor, Rajiv Vidya Mission, SCERT Compound, Opp. E-Gate, L.B. Stadium, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 17-09-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. Joining date of Khammam District SSA site Engineers in TSEWIDC as per GOMS NO. 29 after relieving from SSA, please send the details.
2. The Khammam SSA site Engineers are getting very less salary i.e., Rs 13,917/- only why? please send details.
3. Khammam SSA site Engineers are B Mahesh got high salary.

and more few points.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 08-11-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 12.00 P.M.

The case is called on 26-08-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri K. Vijayabhaskar Reddy, Executive Engineer and the First Appellate Authority / Sri M. Anil Kumar, Chief Engineer, O/o the TSEWIDC, LB Stadium, Hyderabad are present and filed their affidavits stating that reply was given to the appellant vide letter No: E3/2501/RTI ACT/TSEWIDC/2021 dated: 08-10-2021 and filed copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record.

The First Appellate Authority submitted that vide letter No: E3/2501/RTI Act/TSEWUDC/2021 dated: 30-11-2021 informed the appellant that the information sought is not in a form of order/ material which is held by the PIO and is seeking clarification and the PIO cannot deduce some conclusion from the material and supply the conclusion or do research. The PIO further submitted that the information sought is under their purview, hence could not furnish the same.

Keeping in view of the submissions made by the PIO, the appeal is closed.
