Order

Sri Vaddam Shyam, Secunderabad has filed 2nd appeal dated: 21-03-2022 which was received by this Commission on 23-03-2022 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, Circle-11, GHMC, Rajendernagar, Hyderabad and 1st Appellate Authority / O/o the Zonal Commissioner, GHMC, Charminar Zone, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 01-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

2. తమరి కార్యాలయం వద్ద ఉన్న రికార్డుల ప్రకారం GRAMAKANTAM ఫుల్డ్ GHMC CIRCLE-11, RAJENDER NAGAR కార్యాలయంకు, బిల్డింగ్ అనుమతులు ఇచ్చే అధికారం జరిగి కలదు. వాటి యొక్క పూర్తి వివరాలు P.I.O. గారు, తెలియజేయగలరు.
3. తమరి కార్యాలయం వద్ద ఉన్న రికార్డుల ప్రకారం GHMC CIRCLE-11, RAJENDER NAGAR కార్యాలయం నోటరీ (NOTARY) దస్తావేజాల పైన బిల్డింగ్ అనుమతులు, మంజూరు చేస్తార వాటి యొక్క పూర్తి వివరాలు P.I.O. తెలియజేయగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 03-01-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 12.00 P.M.

The case is called on 18-08-2022. The appellant is absent. The APIO / Sri Mohd. Kabeerullah Khan, Town Planning Supervisor, O/o the Deputy Commissioner, GHMC, Circle – 11, Rajendernagar, Charminar Zone, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter No: 252/RTI/TPS/RJNR /C11/CRZ/GHMC/2021 dated: 15-02-2022 and filed copies of the information furnished along with the postal receipt before the Commission.

Heard the APIO and perused the material papers available on record.

The Commission directs the PIO to give point wise reply to the appellant (keeping in view of Section 8, 9, 10 & 11 of the RTI Act 2005) duly attesting within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
