Order

Smt. Ch. Narmada, Komarambheem Asifabad District has filed 2nd appeal dated: -03-2022 which was received by this Commission on 24-03-2022 for not getting the information sought by her from the PIO / Head Master, ZPPS Boys High School, Komarambheem Asifabad District and 1st Appellate Authority / O/o the District Educational Officer, Komarambheem Asifabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 25-01-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 20-01-2022 before the 1st Appellate Authority requesting her to furnish the information sought by her u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing her 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by her and also to arrange to furnish the information sought by her u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 10.30 A.M.

The case is called on 26-08-2022. The complainant is present and filed her affidavit stating that the PIO has not furnished the information. The APIO / Sri A. Bhaskar, Junior Assistant is present and filed affidavit of the PIO / Smt. A. Prameela Head Mistress, O/o the Z.P.S.S. (Boys), Komaram Bheem Asifabad District stating that reply was given to the complainant vide letter No: 08/2021 dated: 18-2-2021 and filed copy of the letter along with the acknowledgement of the complainant before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to furnish the information to the complainant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
