Order

Sri Raju, Ranga Reddy District has filed 2nd appeal dated: 27-03-2022 which was received by this Commission on 28-03-2022 for not getting the information sought by him from the PIO / O/o the District Educational Officer, Nampally, Hyderabad and 1st Appellate Authority / O/o the District Educational Officer, Nampally, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 29-11-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1) Please furnish the Merit Lists of Hyderabad District for the following DSC's as mentioned below in the format given below:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 10-01-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 26-08-2022 at 10.30 A.M.

The case is called on 26-08-2022. The appellant is absent. The PIO / Sri B. Srinivas Reddy, Assistant Director, O/o the District Educational Officer, Nampally, Hyderabad is present and filed his affidavit stating that reply was given to the appellant vide letter Rc. No: Spl/RTI/A4/2022 dated: 25-08-2022 and for the remaining information pertains to 15 years old record, hence requested to give time to furnish the information.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to trace out the records and furnish the information to the appellant within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
