Sri Mohd. Jalili Ali Khan, Hyderabad has filed a Complaint dated: 29-03-2022 which was received by this Commission on 30-03-2022 for not getting the information sought by him from the PIO / O/o the Deputy Commissioner, GHMC, Circle-14, Goshamahal, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 12-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 12.00 P.M.

The case is called on 18-08-2022. The Commission notice dated: 27-07-2022 issued to the complainant was returned by postal Department with an endorsement "No such Person", hence marked absent. The APIO / Sri Srinivas Yadav, Deputy City Planner is present and filed affidavit of the PIO / Sri D. Dhaku Naik, Deputy Commissioner, GHMC Circle – 14, Goshamahal, Hyderabad stating that reply was given to the complainant vide letter No: I/31/T/4/RTI/TPS/C14/KZ/GHMC/2022 dated: 10-03-2022 and filed copy of the reply given along with the postal receipt before the Commission.

Heard the APIO and perused the material papers available on record.

The APIO submitted that on receipt of the Commission notice 27-07-2022 a reply was once again given to the complainant vide letter No: I/31/T/4/RTI/TPS/C14/KZ/GHMC/2022 dated: 16-8-2022.

Keeping in view of the above, the complaint is closed.
