Order

Sri Vollala Srinivas, Jagityal District has filed 2nd appeal dated: 04-01-2022 which was received by this Commission on 07-01-2022 for not getting the information sought by him from the PIO / O/o the District Welfare Officer, Women Children Disabled and Senior Citizens, Jagityal District and 1st Appellate Authority / O/o the District Welfare Officer, Women Children Disabled and Senior Citizens, Jagityal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 16-12-2020 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- A) అంగన్ వాడీ కేంద్రం సెంజర్ B) అంగన్ వాడీ కేంద్రం టీచర్ వేరు ఇంటి పేరుతో సమా తంజి వేరు తేదా భర్త వేరు C) సరుకులు సరఫరా చేసిన తేదీ, నెల, సంవత్సరం D) సరుకు వేరు కిలోలలో మరియు కేటర్లలో E) సరఫరా చేసినటువంటి కొడిగుడ్ల సంఖ్య F) అంగన్ వాడీ కేంద్రంలలో ఉన్నటువంటి విద్యార్థుల మరియు విద్యార్థుల సంఖ్యతో కూడిన అఖిల శ్రావ్యక జాబితా సమాచారం నాబాకునామకు పంపగలరు
- పె సమాచారం అందించండి

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 13-03-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 10.30 A.M.

The case is called on 25-08-2022. The appellant is absent. The APIO / Smt. S. Narsinga Rani, CDPO, Malyala, Jagitial District is present and filed affidavit of the PIO / Dr. B. Naresh, District Welfare Officer, WCD & SC, Jagitial District stating that vide letter No: RTI/8/2020 dated: 22-12-2020 the appellant was requested to pay Rs. 960/- for Xerox charges and obtain the required information and on filing 1st appeal dated: 13-03-2021 vide letter No: C/RTI/2020 dated: 25-03-2021 the First Appellate Authority uphold the reply of the PIO. The PIO filed copy of the letter before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission upholds the reply of the PIO and First Appellate Authority and advises the appellant to pay the requisite fee and obtain the required information.

In view of the above, the appeal is closed.
