## Order

Sri Bethi Raji Reddy, Jagitial District has filed 2<sup>nd</sup> appeal dated: 16-05-2020 which was received by this Commission on 28-05-2020 for not getting the information sought by him from the PIO / O/o the Registrar Judicial, High Court for the State of Telangana, Madina, Hyderabad and 1<sup>st</sup> Appellate Authority / O/o the Registrar General, High Court for the State of Telangana, Madina, Hyderabad.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 25-10-2019 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

1. నేను, తేదీ 30-09-2019 నాడు; ఒక ఆఫీసు, ముకాబ్బలయంట్ల.  
అధికారి, పబ్లిక్ ఇన్ఫర్మేషన్ అండ్ ట్రాన్స్పారెన్సీ, అట్టి ఆఫీసును ప్రార్థించి  
అతనికి వివరంగా తెలుగులో ఆఫీసులో ఉన్న అన్ని వివరాలను గురించి  
వాక్ - బిల్డింగ్, సుబ్-కాంట్రాక్టులను సరిగ్గా ఇవ్వాలని అడగడం మరియు  
అట్టి ఆఫీసులో ఉన్న అన్ని వివరాలను తెలుసుకోవడానికి అనుమతి పంపగలను.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 11-01-2020 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 16-09-2022 at 10.30 A.M.

The case is called on 16-09-2022. The appellant is absent. Sri G. Naresh is present representing Sri A. Kranthi Kumar Reddy, Standing Counsel for O/o the Registrar Judicial, High Court for the State of Telangana, Hyderabad and filed affidavit stating that vide letter ROC No: 367/PIO/JUDL/2019 dated: 18-12-2019 informing the appellant that “his application was directed to be filed”.

Perused the material papers available on record.

The Commission is of the view that the PIO has informed the status of his application, the appeal is closed.
