## **Order**

Sri Ganapathy PB, Kerala has filed a Complaint dated: 24-03-2022 which was received by this Commission on 31-03-2022 for not getting the information sought by him from the PIO / O/o the District Transport Officer, Rajanna Sircilla District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 29-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. With reference to the subject cited above, the following information sought under Right to information Act 2005 :-
2. I have submitted my application dated 15.12.2021 through registered post vide No. RL701020062IN to RTA Rajanna Sircilla regarding Road Tax Refund of my vehicle vide Registration No. TS23E-3019.
3. Intimate the present status of my application regarding Road Tax Refund.
4. SBI Cheque No. 618537 dated 29.01.2022 in favour of Public Information Officer is attached herewith as Prescribed fee of Rs. 10/- (Rupees Ten only).

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 10.30 A.M.

The case is called on 17-08-2022. The appellant is absent, but filed his affidavit stating that the PIO has not furnished the information. The APIO / Ms. G. Kalpana, Senior Assistant, O/o the District Transport Officer, Rajanna Sircilla District is present and filed her affidavit stating that vide letter No: 96/A1/2022 dated: 10-01-2022 the representation was sent to the Transport Commissioner, Telangana State, Hyderabad to look into the matter and take necessary action. The APIO filed copy of the letters communicated before the Commission.

Heard the APIO and perused the material papers available on record. The APIO further submitted that a remainder was sent to the Joint Transport Commissioner & Secretary, RTA Hyderabad, Somajiguda, Hyderabad vide letter No: 12/A1/2022 dated: 08-03-2022 and on receipt of the Commission notice dated: 27-07-2022, vide letter No: 02/RTI/2022 dated: 01-08-2022 the appellant was informed the same.

The Commission directs the PIO to allow the appellant for verification of records on a mutually fixed date and time by giving a prior intimation to the appellant and furnish the required information or give point wise reply to the appellant as sought through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
