Order

Sri Neerati Janardhan, Mancherial District has filed a Complaint dated: 28-03-2022 which was received by this Commission on 06-04-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Dandepalli Mandal, mancherial District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: Nil before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. A. Vijaya, Deputy Tahsildar, Dandepalli Mandal, Mancherial District is present and filed her affidavit stating that reply was given to the complainant vide letter No: B/222/5/2022 dated: 13-03-2022 and filed copy of the information furnished along with the postal receipt before the Commission.

Heard both the parties and perused the material papers available on record. The complainant stated that the PIO has not furnished the details of information as to how the ownership names have been changed. The PIO requested to give time to search the records and furnish the information.

The Commission directs the PIO to make a through search and furnish the information to the complainant duly attesting within Two (2) weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
