## Order

Sri M. Rama Krishna, Nizamabad District has filed 2<sup>nd</sup> appeal dated: 12-10-2021 which was received by this Commission on 07-12-2021 for not getting the information sought by him from the PIO / O/o the Regional Manager, TSRTC, Nizamabad District and 1<sup>st</sup> Appellate Authority / O/o the Regional Manager, TSRTC, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 12-10-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- (2) T.S RTC రిజిస్టర్ మెంబర్స్ నిజామాబాద్ కార్పొరేషన్ కింది పేర్ల వ్యక్తుల కేసుల మూలక నియామక వ్రాసిన ఆర్డర్ల Appointment Order's Copy's కలిగి వాటిని పంపించండి. Education's Certificates పంపించండి. ప్రమోషన్ ప్రమోషన్ Promotions Order's Copy's పంపించండి. జూనియర్ కార్పొరేషన్ కమిటీకి పంపించండి. జూనియర్ కార్పొరేషన్ కమిటీకి పంపించండి. జూనియర్ కార్పొరేషన్ కమిటీకి పంపించండి. జూనియర్ కార్పొరేషన్ కమిటీకి పంపించండి.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 07-12-2021 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 10.30 A.M.

The case is called on 17-08-2022. The appellant is absent. The APIO / Sri R. G. Gibla, Assistant Manager is present and filed affidavit of the PIO / Sri Srinivas Rao, Personnel Officer, O/o the Regional Manager, TSRTC Nizambad, Nizambad District stating that the information was furnished to the appellant vide letter No: Supt/RTI(9/21-RM/NZB dated: 20-12-2021 and filed copy of the covering letter along postal acknowledgement before the Commission.

Perused the material paper available on record and observed that the appellant is seeking personal information of the employees working in O/o the Regional Manager, TSRTC Nizambad, Nizambad District and the PIO has furnished the available information.

The Commission upholds the reply of the PIO & First Appellate Authority and closed the appeal.
