## Order

Sri Nuvvula Krishna, Hyderabad has filed a Complaint dated: 06-04-2022 which was received by this Commission on 07-04-2022 for not getting the information sought by him from the PIO / O/o the District Manager, Telangana State Civil Supply Corporation Limited, Yadradri Bhuvangiri District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 22-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 10.30 A.M.

The case is called on 01-09-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished information. The PIO / Sri M. Gopi Krishna, District Manager, Civil Supplies Corporation Ltd., Yadadri Bhuvanagiri District is present and filed his affidavit stating that the information was furnished to the appellant vide letter No: P.Admn/1/RTI/20-21 dated: 08-02-2022 and filed copy of the information furnished along with the withdrawal letter of the appeal given by the appellant on 27-05-2022 before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO furnished the information to the appellant.

Since the information is furnished, the appeal is closed.
