Order

Sri Lingam Rajaiah, Mancherial District has filed 2nd appeal dated: 11-04-2022 which was received by this Commission on 11-04-2022 for not getting the information sought by him from the PIO / O/o the Revenue Divisional Officer, Mancherial Division, Mancherial District and 1st Appellate Authority / O/o the District Collector, Mancherial Collectorate, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 29-06-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) 13-11-2019 తేదీన నాకు మీ ఆర్డర్లయ్యయల ద్వారా చివరికి విజ్ఞప్తము/బరఖాస్తు ఎవరినో తెలుసుకోవడా ఉద్దేశ్యం చేయబడింది. నా బరఖాస్తు తీసుకు వచ్చిన వివరాల తెలుసుకోవడా.
- 2) మీ ఆఫీస్ చూపుచేత ఆయా నియమ నిబంధనల ప్రకారం నా విజ్ఞప్తాన్ని ఆయా బరఖాస్తులు విజ్ఞప్తాలలో పరిష్కరించాలని ఆ తరువాత నిర్దేశించిన గడువు లాభ్య నా బరఖాస్తును పరిష్కరించుకోవడాకు అనుకూలంగా గల కారణాలు తెలుసుకోవడా. నా విజ్ఞప్తము/బరఖాస్తుకు ఆఫీస్ లోని సృజించిన కారణాలను చూడటం ద్వారా వివరాలను తెలుపండి. ఆ బరఖాస్తు కారణాలను చూడటం ఎవరినో చెప్పిస్తే తెలుసుకోవడా ఆ వివరాలను తెలుసుకోవడా ద్వారా వివరాలను తెలుసుకోవడా సహజంగా ఉండేలా ఆఫీసులో ఉండే గల కారణాలను తెలుసుకోవడా.
- 3) మీ ఆర్డర్లయ్యయల ద్వారా మీ ఆఫీసుల పత్రాల ప్రకారం నా బరఖాస్తును చివరికి గరిష్ట రోజులలో పరిష్కరించాలని తెలుసుకోవడా ద్వారా వివరాలను తెలుసుకోవడా తెలుసుకోవడా.
- 4) నా బరఖాస్తుకు సమాఖ్యకు మీ నా బరఖాస్తుకు తెలుసుకోవడాకు తెలుసుకోవడా.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 13-10-2021 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Sri. Dilesh, Senior Assistant is present on behalf of Sri Dasari Venu, Revenue Divisional Officer, Mancherial Division & District and stated that vide letter Rc. No: T/257/2021 dated: 14-07-2021 the PIO / O/o the Tahsildar, Mancherial Mandal, Mancherial District was directed to furnish the information to the appellant within 3 days under intimation to their office. The APIO filed copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO / O/o the Tahsildar, Mancherial Mandal, Mancherial District to furnish the information to the appellant duly attesting within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
