## **Order**

Sri Lingam Rajaiah, Mancherial District has filed 2<sup>nd</sup> appeal dated: 11-04-2022 which was received by this Commission on 11-04-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Naspur Mandal, Mancherial District and 1<sup>st</sup> Appellate Authority / O/o the Revenue Divisional Officer, Mancherial Division, Mancherial District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 23-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) R.D.O మంజిరాల పం.నం, A/2401/2011-1 తేదీ 16-12-2013 S.R.P. 2 లు 2A ద్వారా ఆంధ్రప్రదేశ్ ప్రభుత్వం సంగ్రహించిన డాక్యుమెంట్లను 15-2-2014 తేదీన మంజిరాల గార్డు డి.పి. TAHSildar Naspur గారి నేతృత్వంలో చేసిన Appellate forum 365 లు డాక్యుమెంట్లు గ్రామీణుల 276. Accepted 89, గ్రామీణుల వివరాలను పంపిణీ చేయమని ప్రార్థనలు చేయబడింది. వారిపై చాలా వట్టు ఉంది. ప్రభుత్వం వారిపై వివరాలను ప్రకటించాలి. డాక్యుమెంట్లను (సర్టిఫైడ్) కాపీలు ప్రకటించాలి.
- 2) గ్రామీణుల సంగ్రహించిన డాక్యుమెంట్లను వివరాలను ప్రకటించి వారిపై చాలా వట్టు ఉంది. వారిపై ప్రభుత్వం వారిపై చాలా వట్టు ఉంది. డాక్యుమెంట్లను (సర్టిఫైడ్) కాపీలు ప్రకటించాలి.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 29-01-2022 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 10.30 A.M.

The case is called on 21-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Smt. K. Shravani, Deputy Tahsildar, Naspur Mandal, Mancherial District is present and filed her affidavit stating that vide letter No: RTI/115/2022 dated: 20-01-2022 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / O/o the Revenue Divisional Officer, Mancherial Division & District since the petition pertains to their office. The PIO filed copy of the letter before the Commission.

Sri. Dilesh, Senior Assistant is present on behalf of Sri Dasari Venu, Revenue Divisional Officer, Mancherial Division & District and stated that the information sought would be available with the PIO / Tahsildar, Naspur Mandal, Mancherial District only.

Heard both the parties and perused the material papers available on record.

The Commission directs both the PIOs to furnish the information to the appellant duly attesting within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
