Order

Sri Lingam Rajaiah, Mancherial District has filed 2nd appeal dated: 11-04-2022 which was received by this Commission on 11-04-2022 for not getting the information sought by him from the PIO / O/o the Depot Manager, TSRTC, Mancherial Depot, Mancherial District and 1st Appellate Authority / O/o the Regional Manager, TSRTC, Adilabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 29-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 1) Mancherial Depo. లో ఏ సచివాలయం కలదు, ఏ ఏజెంట్లు, ఏ ఏజెంట్ల పేర్లు.
- 2) కంప్యూటర్ లో ఏ ఏజెంట్లు ఉన్నారు మరియు ఏ ఏజెంట్ల పేర్లు ఉన్నాయి. (Out sourcing మరియు ఏ ఏజెంట్ల పేర్లు ఉన్నాయి)
- 3) రైల్వే డి.సి. కార్యాలయం, హి.టి.సి., డి.సి. ఆర్.డి., రాజాదియార్, రాజాదియార్ కార్యాలయం మరియు ఏ ఏజెంట్ల పేర్లు ఉన్నాయి. మరియు ఏ ఏజెంట్ల పేర్లు ఉన్నాయి.
- 4) కంప్యూటర్ సమాచారం మరియు ఏ ఏజెంట్ల పేర్లు ఉన్నాయి. మరియు ఏ ఏజెంట్ల పేర్లు ఉన్నాయి.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 03-02-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 10.30 A.M.

The case is called on 17-08-2022. The appellant is absent. Sri R. Shanker, Office Superintendent is present and filed his affidavit of the PIO / Sri V. Ravindernath, Depot Manager, TSRTC Mancherial Depot, Mancherial District stating that the information was furnished to the appellant by hand vide letter No: Sup/RTI-Act(1)/2022-MNCL dated: 04-02-2022 and filed copy of the information furnished along with the acknowledgement of the appellant before the Commission.

Sri V. Venkateshwar, Dy. Superintendent (P) is present representing the First Appellate Authority / Smt. N. Sudha Parimala, Regional Manager, TSRTC, Adilabad District and filed her affidavit stating that vide letter No: AM(P)/RTI(1)/2021-RM-ADB dated: 04-02-2022 direction was given to the PIO to furnish the information to the appellant.

Perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005 and warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
