Order

Sri Md. Razi Ahmed, Nirmal District has filed a Complaint dated: 06-04-2022 which was received by this Commission on 12-04-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Bhainsa Mandal, Nirmal District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 24-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

1. The Land Sy. No. 464 lies under Bhainsa Shivar in Bhainsa Mandal
2. Furnish the Details area of land acres in writing
3. Either the land is endowment, Wakf, Government or Patta land furnish the details as per record
4. Whether the land is an agriculture land or barren land
5. If is presently in the use of crop yielding furnish the name and details yielder
6. Since how many years the above said land is in his possession for crop yielding furnish the details

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 12.00 P.M.

The case is called on 25-08-2022. The complainant is absent. The PIO / Sri P. Surya Prakash, Deputy Tahsildar, Bhainsa Mandal, Nirmal District is present and filed his affidavit requesting to give time to furnish the information.

Heard the PIO and perused the material papers available on record. The Commission took a serious view against the PIO for not furnishing the information to the complainant within the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The Commission warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

The Commission directs the PIO to give a specific point wise reply to the complainant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
