## Order

Sri Abdul Azeem, Nirmal District has filed 2<sup>nd</sup> appeal dated: 23-12-2021 which was received by this Commission on 04-03-2022 for not getting the information sought by him from the PIO / O/o the Depot Manager, TSRTC, Adilabad District and 1<sup>st</sup> Appellate Authority / O/o the Regional Manager, TSRTC, Adilabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 23-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

- 2) అభ్యర్థి అందించిన అధికారులకు అందజేయమని కోరాల్సిన సమాచారాన్ని అందించలేదు.
- 3) అభ్యర్థి అందించిన అధికారులకు అందజేయమని కోరాల్సిన సమాచారాన్ని అందించలేదు.
- 4) అభ్యర్థి అందించిన అధికారులకు అందజేయమని కోరాల్సిన సమాచారాన్ని అందించలేదు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1<sup>st</sup> appeal dated: 04-03-2022 before the 1<sup>st</sup> Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1<sup>st</sup> Appellate Authority even after 30 days of filing his 1<sup>st</sup> appeal, he preferred this 2<sup>nd</sup> appeal before this Commission requesting to take action against the PIO and 1<sup>st</sup> Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2<sup>nd</sup> appeal was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 10.30 A.M.

The case is called on 17-08-2022. The appellant is absent. Sri G. Shivadar, Assistant Manager(P) is present and filed affidavit of the PIO / Sri J. Vijay, Depot Manager, TSRTC Adilabad Depot, Adilabad District stating that the information was furnished to the appellant by hand vide letter No: AMP/RTI(1)/2019-DM:ADB dated: 05-01-2022 and filed copy of the information furnished along with the postal receipt before the Commission.

Sri M. Venkateshwar, Dy. Superintendent (P) is present representing the First Appellate Authority / Smt. N. Sudha Parimala, Regional Manager, TSRTC, Adilabad District and filed her affidavit stating that vide letter No: DS(P)/5(1)/2022-RM-ADB dated: 18-04-2022 direction was given to the PIO to furnish the information to the appellant once again.

Perused the material papers available on record. The Commission is of the view that the PIO has furnished the information to the appellant and also warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the appeal is closed.
