## Order

Sri Srisailam, Mahabubnagar District has filed a Complaint dated: 01-04-2021 which was received by this Commission on 07-04-2021 for not getting the information sought by him from the PIO / O/o the Tahsildar, Balanagar Mandal, Mahabubnagar District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 25-01-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

కలెక్షన్లను స్కాన్, సమాచార పాట్ల-పట్టం-2005 ము అనుసరించి మీ  
యోగ్య నాటు. ప్రభుత్వ పట్టా పర్మిట్ కేసు' వాళ్లని ఇచ్చు గురించి.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 01-09-2022 at 12.00 P.M.

The case is called on 01-09-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri Md. Haneef Khan, Deputy Tahsildar, Balanagar Mandal, Mahabubnagar District is present and filed his affidavit stating that there is no record available and requested to produce the patta certificate.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to make a through search and furnish the information to the complainant duly attesting within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.

The Commission directs to issue **Show Cause Notice** to the present PIO and the then PIO / Sri Md. Haneef Khan, Deputy Tahsildar, Balanagar Mandal, Mahabubnagar District for not furnishing the information / giving reply to the complainant with the stipulated period of 30 days as per Section 7(1) of the RTI Act 2005. The action on the **Show Cause Notice** will be dealt separately.
