Order

Sri Mahmood Hussain Makke, Hyderabad has filed a Complaint dated: 13-04-2022 which was received by this Commission on 16-04-2022 for not getting the information sought by him from the PIO / O/o the Transport Commissioner, Government of Telangana, Khairtabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 28-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Particulars of Information sought:

- (1) Certified copy of note sheet indicating noting by various officials and decision of competent authority on my complaint/grievance dated 24.12.2021.
- (2) Certified copy of investigation report or feedback obtained with respect to grievance raised in my dated 24.12.2021.
- (3) Certified copy of letter directions and / or instruction issued to concerned authority/subordinate office as a follow up action based on my complaint dated 24.12.2021
- (4) In case no action is taken on my complaint dated 24.12.2021, please inform me the name of the officer(s) and staff responsible but failed to take action on my complaint dated 24.12.2021.
- (5) Certified copy of your rules or citizens charter or any other document stipulating the time frame in number of days such a complaint/matter should have been dealt with and resolved by your public authority.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 10.30 A.M.

The case is called on 17-08-2022. The representative of the complainant is present and filed his affidavit stating that the PIO has furnished incomplete information. The PIO / Smt. K. Raja Rajeshwari, Assistant Secretary, O/o the Transport Commissioner & Secretary, RTA Hyderabad, Somajiguda, Hyderabad is present and filed her affidavit stating that reply was given to the complainant vide letter Memo No: 5472/VI/2021 dated: 26-03-2022 informing that the matter is pending with the Joint Transport Commissioner & Secretary, RTA Hyderabad, Somajiguda, Hyderabad for taking necessary action. The PIO filed copy of the letter before the Commission.

Heard both the parties and perused the material papers available on record.

The Commission directs the PIO to give specific reply to the complainant duly attesting within One (1) week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
