## **Order**

Sri D. Rajaiah, Hyderabad has filed a Complaint dated: 11-04-2022 which was received by this Commission on 16-04-2022 for not getting the information sought by him from the PIO / O/o the Managing Director, TSRTC, Bus Bhavan, Musheerabad, Hyderabad.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 07-03-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 17-08-2022 at 10.30 A.M.

The case is called on 17-08-2022. The complainant is present and filed his affidavit stating that the PIO has not furnished the information. The APIO / Smt. G. Parameshwari Assistant Manager (Traffic), O/o the Managing Director, TSRTC, Bus Bhavan, Hyderabad is present and filed her affidavit stating that reply was given to the complainant vide letter No: T1/RTI(07)/2022-OPD(T) dated: 17-03-2022 informing that the application is transferred the PIO / PO & PIO, Hyderabad Region, TSRTC, MGBS- Hyderabad and requested to furnish the information to the complainant. The APIO filed copy of the letter before the Commission.

The PIO / Sri D. Saidulu, Assistant Manager(P), Falaknama Depot, Sri P. Balan, RMD, Senior Assistant, Rajendranagar Depot, Sri K. Mallikarjuna Rao, Assistant Manager (P), Dilshuknagar Depot, Smt. K.V. Sujatha, Assistant Manager (P), HCU Depot and Sri Shaik Raheem, Dy. Superintendent, MP Depot are present and filed their affidavits stating that the information sought was furnished to the complainant.

Heard both the parties and perused the material papers available on record. The APIO further submitted that the information sought pertains to 5 depots and all the 5 depots have furnished the information to the complainant. The action of the PIO is not in accordance to the provisions of the RTI Act.

The PIO ought to have furnished the available & held information in their office to the complainant and for the remaining information, the PIO should have informed the complainant to file separate application before the concerned Public Authority. The PIO in order to provide the information wasted lot of time by referring it to several PIOs with whom the information is available, by which the purpose of furnishing the information in time i.e., within 30 days is defeated with reference to section 7(1) of the RTI Act.

The Commission refers to the memo issued by the Government of India vide memorandum No: 10/2/2008-IR dated: 12-06-2008 by the Ministry of Personnel, Public Grievances & Pension Department of Personnel & Training, New Delhi. (Refer to page No: 77, 78 & 79 of the RTI Act 2005 for reference).

The Commission took a serious view against the PIO and warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
