Order

Sri Naitham Balu, Adilabad District has filed a Complaint dated: 13-04-2022 which was received by this Commission on 18-04-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Gudihathnoor Mandal, Adilabad District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 01-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

- 1) గుడిపాడుపల్లి మండల పరిధిలోని అన్ని గ్రామ శివారాల వారిగా జనవరి-2000 నుండి డిసెంబర్-2021 వరకు ఎంత మందికి NALA (Non-Agricultural Land Assessment) Conversation ఇచ్చినారో వారి వివరాలు గ్రామ శివారాల వారిగా సర్వే నెంబరుతో సహా ఇవ్వగలరు.
- 2) NALA Conversion అనుమతి కొరకు ధరభాస్తుకు ధరభాస్తుదారుడు జతపర్చిన ధృవీకరణ పత్రాలు, అనుమతి పత్రాలు మొదలగునవి యొక్క నకలు కాపీలు ఇవ్వగలరు.
- 3) గుడిపాడుపల్లి మండల పరిధిలోని 2000 సం.రము నుండి 2021 సం.రము వరకు Gift Deed Registration క్రింద ఎంత మందికి భూమి, స్థిరాస్తి బదలాయింపు చేసినారో వాటి పూర్తి వివరాలు మరియు దీనిపై జతచేసిన దస్తావేజుల యొక్క నకలు కాపీలు ఇవ్వగలరు.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 18-08-2022 at 10.30 A.M.

The case is called on 18-08-2022. The complainant is absent. The PIO / Smt. R. Bhagya Laxmi, Deputy Tahsildar, Gudihathnoor Mandal, Adilabad District is present and filed her affidavit stating that reply was given to the complainant vide letter No: RTI/2022 dated: 17-02-2022 informed that the information sought is not traced out and will be furnished once traced out and vide letter No: B/270/2022 dated: 04-06-2022 the available information was furnished. The PIO filed copy of the letters before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission took a serious view against the PIO and warns the PIO not to repeat such lapses in future and strictly adhere to the provisions of the RTI Act 2005.

Since the information is furnished, the complaint is closed.
