Order

Sri Saindla Sridhar, Nirmal District has filed 2nd appeal dated: 08-04-2022 which was received by this Commission on 18-04-2022 for not getting the information sought by him from the PIO / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District and 1st Appellate Authority / O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 03-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 03-03-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 25-08-2022 at 12.00 P.M.

The case is called on 25-08-2022. The appellant is absent. The APIO / Sri T. Gangadhar, Revenue Officer O/o the Municipal Commissioner, Nirmal Municipality, Nirmal District is present and filed his affidavit stating that reply was given to the appellant vide letter No: G1/RTI/17/2022 dated: 21-02-2022 and again vide letter No: G1/RTI/17/2022 dated: 21-04-2022 through private courier. The APIO filed copies of the reply given before the Commission.

Heard the APIO and perused the material papers available on record.

The Commission directs the PIO to send the reply once again to the appellant within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.
