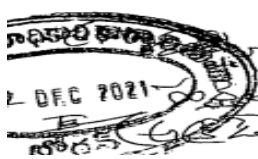

Order

Sri B. Ravi Kumar, Nizamabad District has filed 2nd appeal dated: 13-04-2022 which was received by this Commission on 18-04-2022 for not getting the information sought by him from the PIO / O/o the Revenue Divisional Officer, Bodhan Division, Nizamabad District and 1st Appellate Authority / O/o the District Collector, Nizamabad Collectorate, Nizamabad District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 21-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

3. ఇవ్వలేకపోయినది షాట్లు కడప జిల్లాలోని - ఉత్పాదక విభాగం ఏలా నిర్వహించారు తెలుపగలరు.
4. షాట్లు కడప జిల్లాలో ఏ ఉత్పాదక సంస్థలలో ఇవ్వగలరు గలది ఏ ఉత్పాదక బాధ్యతలో ఉన్న వారికి వివరాలు తెలుపగలరు.
5. ఉత్పాదక ఇవ్వలేకపోయినది షాట్లు కడప జిల్లాలోని నియమ, నిబంధనలు ఏవిటే తెలుపగలరు.



అందుకు అనుగుణంగా ఇవ్వలేకపోయినది షాట్లు కడప జిల్లాలోని ఉత్పాదక సంస్థలలో ఇవ్వగలరు గలది ఏ ఉత్పాదక బాధ్యతలో ఉన్న వారికి వివరాలు తెలుపగలరు.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 31-01-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 15-09-2022 at 10.30 A.M.

The case is called on 15-09-2022. The appellant is absent. The PIO / Sri Mk. Muntajibuddin, Divisional Administrative Officer is present and filed affidavit of Sri S. Rajeshwar, Revenue Divisional Officer, Bodhan Division, Nizambad District stating that vide letter No: A2/200/2022 dated: 25-02-2022 the application was transferred u/s 6(3) of the RTI Act 2005 to the PIO / O/o the Tahsildar, Bodhan Mandal, Nizambad District with a request to furnish the information to the appellant and vide letter No: D/260/2022 dated: 29-03-2022 a reply was given to the appellant. The PIO filed copy of the same before the Commission.

Heard the PIO and perused the material papers available on record. The Commission is of the view that the PIO has given appropriate reply to the appellant.

In view of the above, the appeal is closed.
