Order

Smt. G. Kalpana, Suryapet District has filed a Complaint dated: 13-04-2021 which was received by this Commission on 19-04-2022 for not getting the information sought by her from the PIO / O/o the Superintendent, Prohibition & Excise, Nalgonda District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 27-12-2021 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in her application annexed.

*From wife of G. Nageender
Head Constable, Excise Station,
Nalgonda regarding sale to
issue of salary certificate of
G. Nageender, He, for filling in
the vacancy for Civil Judge Court,
Suryapet for transaction of arrears
nonce allowance.*

Stating that the PIO has not furnished the required information even after 30 days of filing her application, she preferred this Complaint before the Commission requesting to arrange to furnish the information sought by her u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 02-09-2022 at 10.30 A.M.

The case is called on 02-09-2022. The complainant is absent. The PIO / Sri B. Chanakya Assistant Prohibition & Excise Superintendent, Nalgonda District is present and filed his affidavit vide letter No: 518/2021/D dated: 29-12-2021 as per Section 11 of RTI Act 2005 a letter was addressed the 3rd party with a request to give his consent whether to furnish the information sought or not and on 01-02-2022 the 3rd party requested not to give any such information and vide letter No: 51/2022/D dated: 11-02-2022 the same was informed to the complainant that the information sought could not be furnished. The PIO filed copies of the same along with the postal receipt before the Commission.

Heard the PIO and perused the material papers available on record.

The Commission directs the PIO to furnish the information to the complainant duly attesting within One (1) Week from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the complaint is closed.
