Order

Sri B. Srinivasa Reddy, Hyderabad has filed 2nd appeal dated: 18-04-2022 which was received by this Commission on 20-04-2022 for not getting the information sought by him from the PIO / O/o the Tahsildar, Narwa Mandal, Narayanpet District and 1st Appellate Authority / O/o the Revenue Divisional Officer, Narayanpet District.

The brief facts of the case as per the appeal and other records received along with it are that the appellant herein filed an application dated: 31-01-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application:

POINT 1. జిల్లా స్థానిక ప్రభుత్వం లోని బలహీన వర్గాలకు, ప్రభుత్వం సొంత

రకు P.I.O గారిని అభ్యర్థించడం జరిగింది.

POINT 2. ప్రభుత్వం లబ్ధిదారులకు ఇచ్చిన House site వెళ్ళా వెళ్ళ
మొదటి నకలు ప్రవేశించి ఇవ్వమని సందిగా నా
రకు P.I.O గారిని అభ్యర్థించడం జరిగింది.

POINT 3. ప్రభుత్వం నివాసం ఉన్న ఖాళీ House site ఏసెంబ్లీ రూం
లకు సేకరణ కేటాయింపు జరిగింది. ఆ భూమి వ్యాపారులు,
విక్రయ వివరాలు ఇవ్వండి.

POINT 4. ప్రభుత్వం House sites పొందిన లబ్ధిదారులు ఏ బలహీన
వర్గాలకు చెంది ఉన్నారో ఆ వివరాలు ఇవ్వండి.

Stating that the appellant did not receive the information from the PIO, the appellant filed 1st appeal dated: 11-03-2022 before the 1st Appellate Authority requesting him to furnish the information sought by him u/s 19(1) of the RTI Act.

Stating that the appellant did not get the information from the PIO / 1st Appellate Authority even after 30 days of filing his 1st appeal, he preferred this 2nd appeal before this Commission requesting to take action against the PIO and 1st Appellate Authority for not furnishing information sought by him and also to arrange to furnish the information sought by him u/s 19(3) of the RTI Act, 2005.

In view of the above, the 2nd appeal was taken on file and Notices issued to both the parties for hearing on 22-07-2022 at 10.30 A.M.

The case is called on 22-07-2022. The appellant is present and filed his affidavit stating that the PIO has not furnished the information. The PIO / Sri Vasudev Rao, Deputy Tahsildar, Narwa Mandal, Narayanpet District is absent.

Heard the appellant and perused the material papers available on record and observed that the appellant filed 6(1) application dated: 31-01-2022 seeking information on 7 points and the PIO has neither furnished the information to the appellant nor appeared for the hearing held on 22-07-2022. The Commission is of the view that there is a gross negligence and disrespect towards the provisions of the RTI Act 2005.

The Commission directs the PIO to furnish the information to the appellant within Two (2) Weeks from the date of receipt of this order through Registered post with acknowledgement due and to report compliance to the Commission.

With the above direction, the appeal is closed.

Issue **Show Cause Notice** to the present PIO and the then PIO / Sri Vasudev Rao, Deputy Tahsildar, Narwa Mandal, Narayanpet District for not furnishing the information to the appellant within the stipulated period of 30 days as per Section 7(1) of RTI Act 2005 and even after the direction given by the First Appellate Authority. The action on the **Show Cause Notice** will be dealt separately.
