Order

Sri V. Ravinder Reddy, Hyderabad has filed a Complaint dated: 10-04-2022 which was received by this Commission on 11-04-2022 for not getting the information sought by him from the PIO / O/o the District Collector, Mancherial Collectorate, Mancherial District.

The brief facts of the case as per the Complaint and other records received along with it are that the Complainant herein filed an application dated: 28-02-2022 before the PIO requesting to furnish the information under Sec. 6(1) of the RTI Act, 2005, on the following points mentioned in his application annexed.

Stating that the PIO has not furnished the required information even after 30 days of filing his application, he preferred this Complaint before the Commission requesting to arrange to furnish the information sought by him u/s 18(1) of the RTI Act, 2005.

In view of the above, the Complaint was taken on file and Notices issued to both the parties for hearing on 21-07-2022 at 12.00 P.M.

The case is called on 21-07-2022. The complainant is absent. The representative Smt. M. Sherisha, Section Assistant is present on behalf of the PIO / Sri Madhusudan Naik, Additional Collector / District Revenue Officer (FAC), Mancherial District and filed affidavit stating that vide letter Rc. No: A208/54/2022 dated: 09-03-2022 the application was transferred u/s 6(3) of RTI Act 2005 to the PIO / O/o the Municipal Council, Chennur Municipality, Mancherial District with a request to furnish the information to the appellant. The representative of the PIO filed copy of the letter before the Commission.

Sri N. Raj Kumar, Junior Assistant is present on behalf of the PIO / O/o the Municipal Council, Chennur Municipality, Mancherial District and stated that point wise information was furnished to the complainant vide letter No: 732/MCC/2022 dated: 16-07-2022 and filed copy of the information furnished along with the postal receipt before the Commission.

Perused the material papers available on record and the Commission is of the view that the PIO has furnished the information to the complainant.

Since the information is furnished, the complaint is closed.
